What is REDD.plus?



A platform that allows countries to sell REDD+ Results directly to businesses, individuals and governments looking to retire carbon credits



Built by the Coalition for Rainforest Nations to serve the interest of member countries

How does it work?



Each ton of your REDD+ results from the UNFCCC Info Hub receives a serial number and becomes part of the national registry run by S&P Global



REDD+ results are now RRUs that can be bought directly on REDD.plus



Fewer entities involved in trading means more money flowing to your country and communities






REDD.plus brings stakeholders together on a transparent and low-cost platform






Supply – The first UNFCCC-certified credits are ready to buy, you can be the next seller.
